Years as a girl member **plus** years as an adult member are combined and counted toward this recognition. This request is for membership years totaling 20 years and above.* The *Membership Numeral Pin (20 years and above)* is provided by Girl Scouts of Connecticut.

Form of Recognition:

- Award is a membership numeral pin attached to a gold chain.
- Twenty-year and above pins are presented at the Girl Scouts of Connecticut Annual Meeting on May 23, 2012.

Criteria:

- Candidate must be a registered adult member of Girl Scouts.
- Total membership years must be 20 or more.
- Candidate must have completed the years for which she/he is applying (e.g. the soonest you may apply for the 20-year pin is October 1st of your 21st year.)

Nomination:

- This request is completed by the candidate (self-nomination) or another adult member of Girl Scouts.
