

OFFICIAL RULES FOR THE COOKIE JACKPOT SWEEPSTAKES NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1. SPONSOR: The Cookie Jackpot Sweepstakes (the "Sweepstakes") is sponsored by Girl Scouts of Connecticut ("Sponsor"), located at 340 Washington St, Hartford, CT 06106. This Sweepstakes is in no way sponsored, endorsed, or administered by, or associated with any third-party retailer or platform.
- 2. ELIGIBILITY: The Sweepstakes is open to legal residents of Connecticut who are 18 years of age or older at the time of entry. Employees, officers, and directors of the Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members (spouses, parents, children, and siblings) or members of the same household are not eligible to enter or win.
- 3. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:01 AM ET on 3/21/2025 and ends at 11:59 PM ET on 4/27/25 (the "Sweepstakes Period"). All entries must be received by the deadline to be eligible.
- 4. HOW TO ENTER: A. Purchase Method: Participants will receive one (1) entry into the Sweepstakes for every five. (5) or more boxes of Girl Scout Cookies purchased in a single transaction at an official Girl Scouts of Connecticut Cookie Booth. Customers must scan the Sweepstakes QR Code at the booth and complete the online entry form, providing their name, phone number, and email. B. Free Entry Method (No Purchase Necessary): To enter without making a purchase, scan the Sweepstakes QR Code displayed at Girl Scout Cookie Booths. Complete the online entry form with your full name, phone number, and email. The online form will be available throughout the Sweepstakes Period.
- 5. ENTRY LIMITS: Each participant may receive a maximum of 10 entries during the Sweepstakes Period, regardless of entry method. Multiple transactions of 5+ boxes are allowed but limited to ten total entries per participant.
- 6. PRIZE: One (1) winner will receive a \$500 Visa Gift Card. The total Approximate Retail Value (ARV) of the prize is \$500.
- 7. WINNER SELECTION & NOTIFICATION: A random drawing will be conducted on 4/29/25 from all eligible entries received. The potential winner will be notified via phone and/or email within 5 business days of the drawing. The winner must respond within 7 days to claim the prize. If the winner does not respond, is ineligible, or fails to provide the required documentation (if applicable), an alternate winner may be selected.
- 8. ODDS OF WINNING: The odds of winning depend on the number of eligible entries received. It is estimated at 1 in 2,369.
- 9. GENERAL CONDITIONS: By entering, participants agree to abide by these Official Rules and the decisions of the Sponsor, which are final and binding. Sponsor reserves the right to disqualify any participant found tampering with the entry process or violating these rules.
- 10. PUBLICITY RELEASE: By accepting the prize, the winner grants Sponsor permission to use their name, likeness, and city of residence for promotional purposes without additional compensation, except where prohibited by law.
- 11. LIMITATION OF LIABILITY: Sponsor is not responsible for lost, late, misdirected, or incomplete entries due to technical failures or other issues. Sponsor reserves the right to modify, suspend, or terminate the Sweepstakes

if fraud, technical failures, or any other factor impairs the integrity of the promotion.
